A certified letter will be sent to Mr. Thompson stating that if he is in violation of the covenants in the future (Mr. Thompson stated that his tenant will move out by May 2011) it is the intention of the board to file a lien against his property for any fines imposed by SPOA. Matt Howell was present and wanted to apologize for any problems that he, as a tenant of Mr. Thompsons' residence, might have caused.

Greg and Cynthia Nelson who reside at 1163 Winslow were present to discuss the removal of trees. The Nelson's were informed by the board that the removal of trees is a DRC issue and they were directed to notify the DRC.
