<u>Community Relations</u> – Mr. Cogswell gave an update on the cleanup and party in the 'hood' plans.

<u>Open Space Trails</u> – Mr. Powers gave an update regarding a letter that had been sent to Congressmen Salazar and Udall and Senators Salazar and Allard regarding the Forest Service FY 2007 Initiative. Mr. Powers stated that the current plan as proposed would probably not go through. The area behind the Cordillera Valley Club was discussed. The Committee will not meet in April, but will resume in May.

<u>Weed Control</u> – Mr. Spiker reported that the committee held a meeting on April 17<sup>th</sup>. A training date has been set for June 8<sup>th</sup> at 9:00 a.m. at the Singletree Community Center. Master gardeners, captains, etc will attend.
