A Special Meeting of the Board of Directors of Berry Creek Metropolitan District was called to order by Chairman Gregory, on October 15, 2014, at 10:30 a.m. noting a quorum was present.

2015 Budget The Board conducted a line item review of the preliminary 2015 budget. In addition to various revisions to the preliminary budget, the Board requested an RFP be distributed for the 2014 audit. It was agreed to budget for personnel costs in 2015. It was noted the warranty period for the west entrance landscape installation has expired and the Board requested proposals from Garden Creations and STI Services for maintenance of that landscape in 2015. The water recirculating pump for Charolais Pond would cost \$21,000 to replace so the Board agreed to notify the Charolais Circle residents that the pump will not be replaced.

ECA Budget Upon motion duly made and seconded it was unanimously

RESOLVED to approve the contribution to ECA for 2015.

The Board directed the ECA representative to report to ECA that while Berry Creek is continuing its participation for 2015 it does not plan to provide funding for future years and therefore it is important for ECA to develop alternative funding sources.
