Re-vegetation The Board reviewed the proposal by Sonnenalp of Vail Fine Gardens, LLC in the amount of \$23,375 to re-vegetate the upper wall area of the Singletree entrance. After discussion the board agreed to not accept the proposal at this time.

Control

The Board discussed the mosquito problem at Charolais Circle Pond and requested that staff inquire about the costs to have the pond sprayed.

Old Business

Spur Road

Director Pinney reported that the Engineering Firm Selection Committee of the Edwards Area Task Force interviewed the top three candidates for the Spur Road interchange design. The top choice of the Eagle County representative and the Edwards Metropolitan District representative is Felzburg Holt & Ullevig Engineering (FHU) and Berry Creek's and Arrowhead's first choice is Carter Burgess. Director Pinney expressed her opinion is that Carter Burgess had a better presentation, has a larger organization that would be better able to perform the project and is better qualified to perform the aesthetic elements of the design. FHU's proposal is less expensive than Carter Burgess's proposal and the County feels that FHU is very qualified to perform the technical engineering aspects of the project and that the aesthetic elements could be added at a later time.
