EAGLE RIVER WATER AND SANITATION DISTRICT MESQUITE DRIVE WATER PUMP REPLACEMENT PROJECT

Mike Saxton and Jose Velazquez from Tetra Tech, and Carter Keller and Jeff Schneider from Eagle River Water & Sanitation District, explained the nature of the water pump replacement project on Mesquite Drive. Located in an unsafe confined space, the existing booster pump has reached the end of its useful life. The new pump will be accessible from the road and the current plan shows a 26' long wall visible from the road with stone and a metal railing for the path that will go over it to access the hiking/biking trail above. No street nor driveway closures anticipated during the work. Plan to take design through Singletree's Design Review process. Will begin work in September and be complete by the end of the year.
