### **Minutes of the Regular Meeting of the Board of Directors of Berry Creek Metropolitan District on June 27, 2019**

The Regular Meeting of the Board of Directors of the Berry Creek Metropolitan District (BCMD), Eagle County, Colorado held on June 27, 2019, at 3:00 p.m., at the Singletree Community Center, 1010 Berry Creek Road, Edwards, Eagle County, Colorado, in accordance with the applicable statutes of the State of Colorado. The Board met in joint session with the members of the Board of Directors of the Singletree Property Owners Association (SPOA). **RESOLUTION AUTHORIZING ONLINE NOTICE OF PUBLIC MEETINGS**

As of August 1, House Bill 19-1087 authorizes the District to post full and timely notice of its meetings no less than 24-hours prior to its meeting on the District's public website ([www.singletreetoday.com](http://www.singletreetoday.com)) at no charge to the public and the District will maintain the Singletree Community Center as the one designated physical location for posting meeting notices. The Board determined these noticing options will provide improved notice to the District's residents. Following discussion, by motion duly made and seconded, it was unanimously

**RESOLVED** to adopt the Resolution Authorizing Online Notice of Public Meetings.

**IGA FOR MOSQUITO CONTROL IN EDWARDS**

Edwards Metro District provides mosquito control services for the Edwards area and has done so for many years. The IGA codifies cost sharing for mosquito control service that has occurred between Arrowhead, Berry Creek, Edwards Metro Districts and Lake Creek Village, LLC, over the years. Following discussion, by motion duly made and seconded, it was unanimously

**RESOLVED** to enter into the IGA for Mosquito Control Service.

**MAY FINANCIAL REPORT**

Two Certificates of Deposit renew in 2020, Marchetti and Weaver will shop for the best rates on renewal, unless it is determined the cash is needed for capital projects. Ken noted that a one mil increase in the tax rate generates approximately \$78,000 per year. Currently the District has approximately \$200,000 per year to spend on capital projects. Following discussion, by motion duly made and seconded, it was unanimously

**RESOLVED** to accept the May 2019 financial statements as presented.

### UPDATES

UERWA – Lake Powell and Lake Mead increased, with peak expected in September. Ongoing concern about the long-term draught situation. The Board questioned the Water District funding operations from the capital budget.

Draft Audit Report – Will distribute the Management Discussion electronically. The committee should review the audit and talk to the auditors to answer questions.

Joint BCMD/SPOA Committees – Furthering the partnership, the boards would like to establish joint BCMD/SPOA committees.

2020 Maintenance Contracts – BCMD will explore alternative options for 2020 maintenance contracts, goal to expand relationship with the Sonnenalp Club, recognizing it is mutually beneficial to ensure the Club's ongoing success.

Community Manager Report –

- Requested to open the gym at 5:30 AM. It currently opens at 5:45 AM in deference to the neighbors.
- Update Community Center rental agreement to a 60-day cancellation policy.
