The Board reviewed the proposal from Shaw Electric to update lights throughout community. After rebates the net cost to the District would be \$9,897 to update the lighting systems throughout the District. Although the rebates don't cover all of the costs, the new lights will lower electricity consumption and maintenance costs and are therefore more environmentally friendly. It was noted the District budgeted \$12,000 for light maintenance. By motion duly made and seconded it was unanimously

RESOLVED to approve the proposal from Shaw Electric to update the lighting system throughout Singletree.

The draft 2015 audited financials were presented to the Board. The District's water right values were questioned and it was clarified that they will be presented by Eagle River Water and Sanitation when available. By motion duly made and seconded it was
