Call To Order

The Regular Meeting of the Board of Directors of Berry Creek Metropolitan District was called to order by Director Cohen, on July 26, 2005, at 3:30 p.m. noting a quorum was present.

Bike

Path

Mr. George Gregory, a Singletree property owner, came before the Board to retrieve feedback regarding the bike path located east of the intersection between Berry Creek Road and June Creek Road. Mr. Gregory stated the path currently crosses the property he is developing but there is no easement

for the path across the property. Mr. Gregory indicated he would be willing to permit the path to remain on the property if the District would like to keep it or it could be removed. Mr. Gregory commented that he would prefer to remove the path to aesthetically improve the development of his property. The Board commented that the path is misleading in that it dead ends and agreed to consent to the removal of the bike path.

Hackamore

Berm

Mr. John Perkins, owner of JMP Architects and Mr. Glen Wood, a representative of Canwest, L.L.C., the developer and owner of Lot 2, 0068 Hackamore appeared before the board to review and finalize the terms of the encroachment agreement between Berry Creek Metropolitan District and Canwest, L.L.C. The agreement allows for a berm to be constructed on District property adjacent to 0068 Hackamore subject to the District's outlined conditions. Mr. Wood agreed to the terms of the agreement. By motion duly made and seconded it was unanimously

RESOLVED to approve the encroachment agreement as submitted and to authorize any District officer to execute the agreement on behalf of the District.

Director Cohen reported that the step enhancement on Mesquite Trail is completed. He also stated that he has received positive remarks regarding the improved safety of the trail.

Director Cohen reported that Ms. Beth Reilley, the WECMRD coordinator, has inquired about using the community center at no cost for preschool activities. The Board raised some possible issues such as who would be responsible for clean-up and would the kids be big enough to use the adult bathrooms. The Board requested that Mr. John Carlson find out more information regarding the proposed activities.

Balata's

Noise Level

It was reported that a few singletree residents will be closely tracking the noise level at Balata and will continue to make efforts to control the noise level by voicing concerns to appropriate parties such as the Eagle County Code Enforcement Office.

Playground Equipment

Director McInerny presented a finalized estimate by Made in the Schade in the amount of \$32,220.50 for installation of the proposed playground climbing structures that could be installed on the playground in Chip Ramsey Park. Director McInerny also presented photographs of a similar climbing structure combination that is located on the Cordillera playground. After review and discussion and by motion duly made and seconded it was unanimously

RESOLVED to authorize the purchase of the playground climbing structures from Made in the Schade in the amount of \$32,220.50.

Director McInerny volunteered to coordinate the purchase and installation of the structures.
