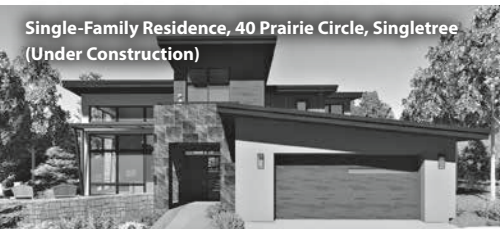

was launched in 1998 and was successful by filling a niche for developer/builders that needed reasonable fees and simpler “builder set” documentation, but with the twist of smart, cutting edge mountain design. John embraced the three-dimensional architectural programs; thereby keeping ahead of the architecture technology that larger firms were ignoring. All the pieces were falling into place but John realized that he could use help, not just with the work load, but with technical peer review, design critique, and specialized construction knowledge. This is where Jeff Manley enters the story.

Jeffrey P. Manley A.I.A, had also been chasing his dream of working on high end residential projects by working since 1996 for a mid-sized Vail Valley architecture firm. Jeff had come to the Vail Valley for the lifestyle and stayed for the great and fulfilling architectural work. Previously, he had already cut his teeth on large commercial / industrial projects in Illinois after he had graduated from the architecture program at Southern Illinois University. John saw the potential in creating a business partnership in 2005 with Jeff. With similar passions for skiing, mountain biking, music, the mountains, and architecture, they became great friends. 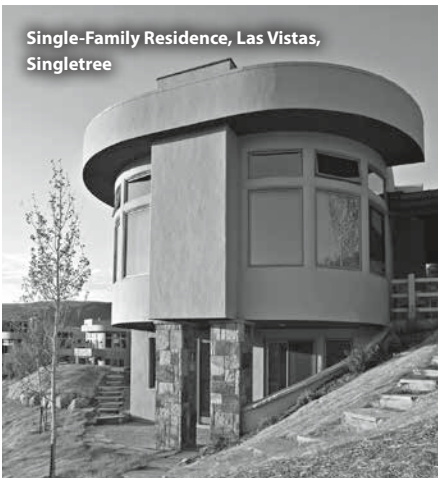

“When the dog is ready, the owner will appear,” explains Cynthia. And so it was with the arrival of Cammie Jean. In February, Cynthia had helped rescue another Australian Shepherd, Cooper, only to find out a few days later that Cammie had been born on March 1. With Cooper now living with his other foster parent, Tim, Cammie’s arrival was meant to be.

Cammie is a very active, very confident puppy. Nearing 6 months of age, she reminds Cynthia of Miss Tillie with her sweet disposition; she loves everybody and everybody loves her. Cynthia has not raised a puppy in forty years, and she confesses honestly, “it’s very strenuous. It’s like having your first baby! I worry about what she is eating, what she is grabbing, if she is running away ... I worry about everything.”

Cammie Jean entered her first competition in July at the American Kennel Club (AKC) show at the Eagle County Fairgrounds, sponsored by the Roaring Fork Kennel Club. She took First Place in the Beginner Puppy Class in her group, the herding group. While stage Mom Cynthia watched anxiously from the sidelines, Miss Tillie’s breeder Ray Schafer showed her and was thrilled to report that “she showed like a pro!”

The next competition was her first ASCA show where she won in the 4 - 6 Month Puppy class. This award recognizes her as the top of her breed. In October, she will progress to the 6 - 9 Month

Puppy Class, at which time any points earned count toward championship status.

Cynthia explains that Cammie is competing in conformation, which is essentially, “a beauty contest. In order to prepare for competition,” she elaborates, “a dog must be solid on a leash, able to stand in the proper position, and to be handled by the judge without distress – for the dog or the judge.” Like Miss Tillie, Cammie Jean has the same inherent ability to assume the proper position naturally, referred to as a “free stack”, rather than having to be placed in position by a handler.

Cynthia continues to train Cammie on a regular basis, with assistance from local dog trainer, Mark Ruark. The most difficult challenge is walking on a leash, but she has conquered the commands “Down” and “Come”. Cammie has made her debut at Walking the Dog and is reported to get along well with other dogs, including her foster brother Cooper.

Cammie Jean is a sweet girl with championship promise. Cynthia is so pleased to have Cammie now in her life and looks forward to enjoying a long career of racking up the ribbons!

Bleesz, a fine art photographer and resident of Singletree, has been selected to participate in the Colorado Photographic Arts Center 2016 Annual Members Exhibition with his black and white photograph entitled, “Abandoned Freezer & Fridges In The High Country”. Having begun operations in 1963, CPAC is considered one of the oldest established fine art photographic galleries west of the Mississippi, and Raymond has had numerous photographs displayed at CPAC over the years. The photographer has been a member of CPAC since 1976 when he made the decision to pursue fine art photography and has been ever doing so ever since.

The photographic image Raymond submitted of the abandoned, starkly white appliances stacked up against a

dilapidated shed in the high country ranching area in Eagle County was an oddity, and yet there was symmetry in the white rectangular shapes against the gray/black boards of the shed & distant horizon.

The juror for the Colorado Members Exhibition was Tim Wride, Curator of Photography at the Norton Museum of Art in West Palm Beach, Florida. Mr. Wride viewed over 300 images submitted by 73 artists. Mr. Wride selected this image based on its strength, its idea, and its abnormality in the ordinary.

Technically, Raymond does not rely upon photo manipulation; rather he is interested in “reality”. Fluent in color, as well as black and white, Raymond actually prefers black and white and states: “Color photography is easier



to comprehend and do, and is psychologically pleasing to the eye, however, black and white photography is harder to master, has a longer tradition, is harder to understand and is more graphic. A black and white photo needs to make a serious ‘statement’ to be effective.”

Most recently, Raymond won 1st Place at the local Colorado Mountain College – Vail Valley Arts Guild Photographers (VVAGP) show at the CMC campus in early August, with his piece entitled, “Rain, Hail On The Old Homestead Piney Creek Ranch”. Raymond is also a Co-Founder of the VVAGP group. Raymond’s photos can be seen at the Art of the Vail Valley Gallery in Avon, as well as Brush Creek Dry Goods in the Riverwalk Complex in Edwards.

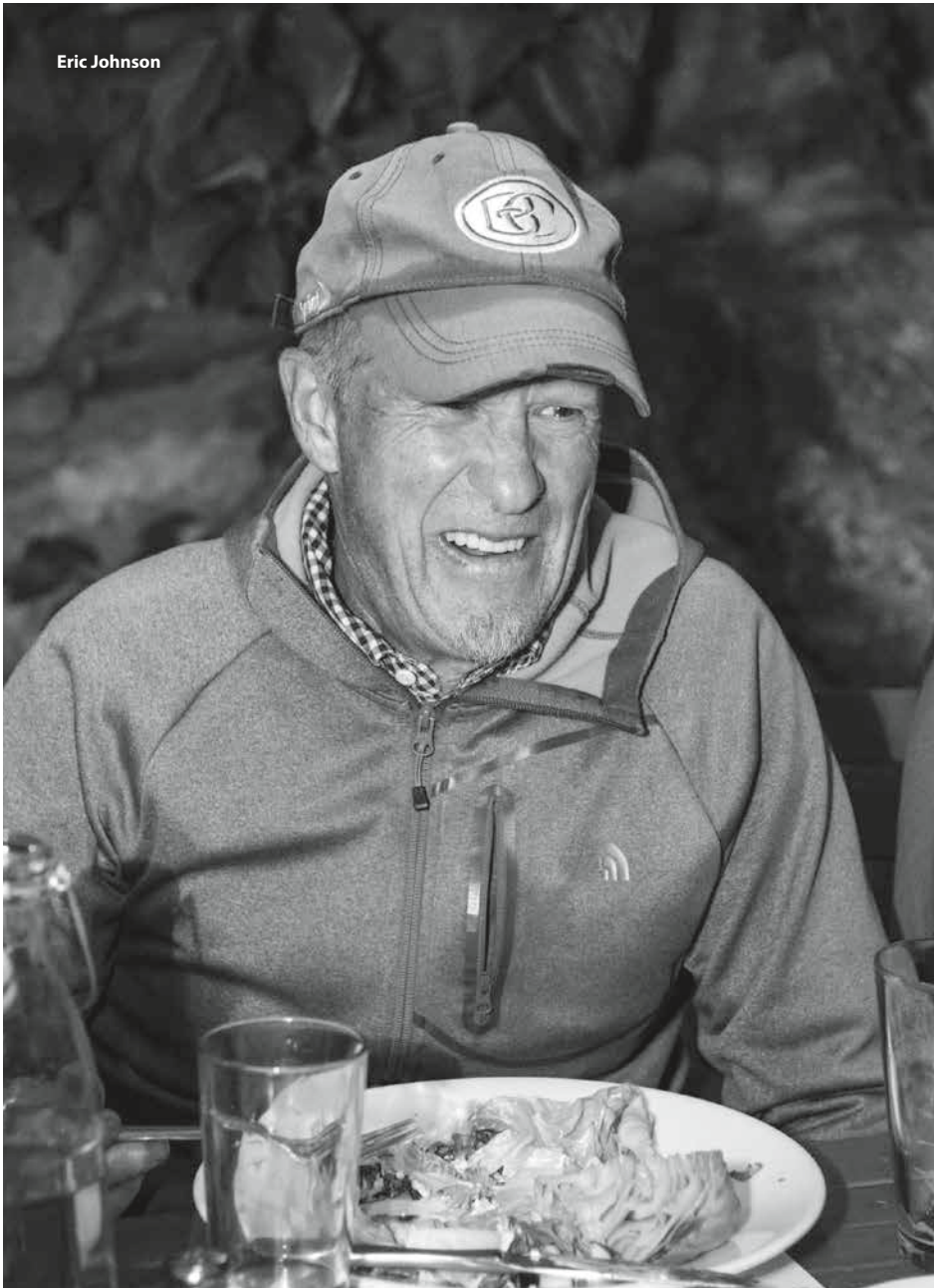
Perfect Night on the Gore Range Brewery Patio

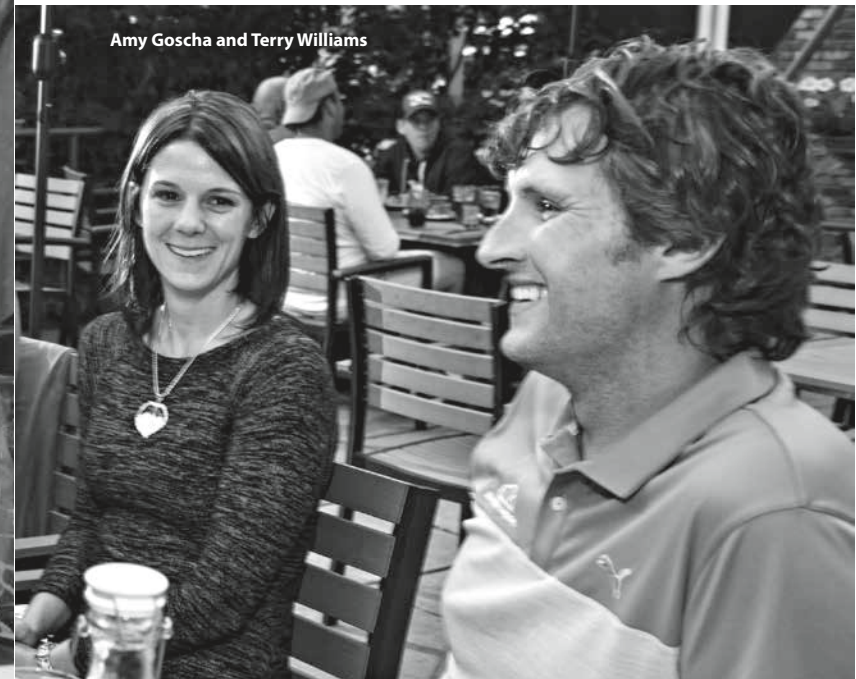
atmosphere and good beer". The atmosphere scored a 5 out of 5 across the board and one guest summed up the overall experience with the comment, "The patio is an amazing spot! Can't wait to come back!"

Appetizers were delivered to the table immediately, including hummus and avocado dip, an antipasto plate offering a selection of prosciutto, salami, fresh mozzarella and manchego cheese, and the group's favorite, the caramelized onion tart with honey, bleu cheese, arugula and walnuts on a puff pastry.

Michelle Hayes particularly liked the sweet flavor of the bread while another guest described it as "very delicious with the arugula". Diane Levin described the starter as "Wonderful! And very flavorful with a great flaky crust." Jean Mitchell named the onion tart as her "very favorite appetizer". The hummus, with praise for its presentation, received varying reviews, ranging from "very good with fresh flavor" to "a little bland and needing some zip".

The Gore Range Brewery offers classic American pub fare with a twist, including salads, soups, sandwiches, wood oven pizzas, entrees and side dishes. On this particular evening, our guests were offered a selection of the restaurant's signa-

...ture dishes, all of which were rated a 4 or 5 by the reviewers for both flavor and presentation.

The grilled salmon served with asparagus risotto certainly stood out among the dinner selections. Many guests remarked on the excellent preparation of the salmon; Michelle Hayes specifically noted the “great texture of the salmon” and commented it was “grilled perfectly”. She went on to describe the accompanying asparagus risotto as “delicious”, echoed by many who claimed the dish to be “outstanding”.

Gore Range Brewery is known for their hearty sandwiches, and both the pulled pork sandwich and the BBQ spice rubbed brisket dip served on a pretzel roll were well received, particularly with note for the crunchy French fries. The BBQ Spice Rubbed Brisket Dip was simply described as “so delicious!”

For lighter fare, guests were offered a choice of the house salad or the wedge salad with a choice of steak, salmon or chicken. Eric Johnson named the wedge salad with “tender

and succulent” salmon as his favorite dish, and another guest described the entrée salad as, “delicious, with the salmon cooked perfectly”.

Dessert options included an oreo tart and a berry trifle. Overwhelmingly, the Oreo tart, a fudgy chocolate mousse served on an oreo crust with a scoop of vanilla ice cream and drizzled with chocolate, was the winner! Jean Mitchell remarked “Wow! A perfect dessert to share” and referred to the dish as a “lover’s dessert”. While the Oreo tart was enjoyed as being “nice and rich” by Felicia, and “sinful” by Eric Johnson, the berry trifle offered an option as a lighter finale to the meal, with a suggestion that while delicious, maybe a few more berries would make it even better.

All 19 of our guests had been to the Gore Range Brewery in the past; and all 19 responded that they would return and would recommend the restaurant to a friend. And in keeping with the spirit of these events, every guest reported that they met someone that they did not already know in the

neighborhood. Amy Goscha and Terry Williams will be married in October, and as they move into their new home on Charolais Circle, they will have already met their new neighbors, Burt and Diane Levin! Lai White summed up the evening as a “nice visit with Singletree residents and making new friends”. Lawyers met neighboring lawyers, brokers met fellow brokers and bankers met former career bankers. 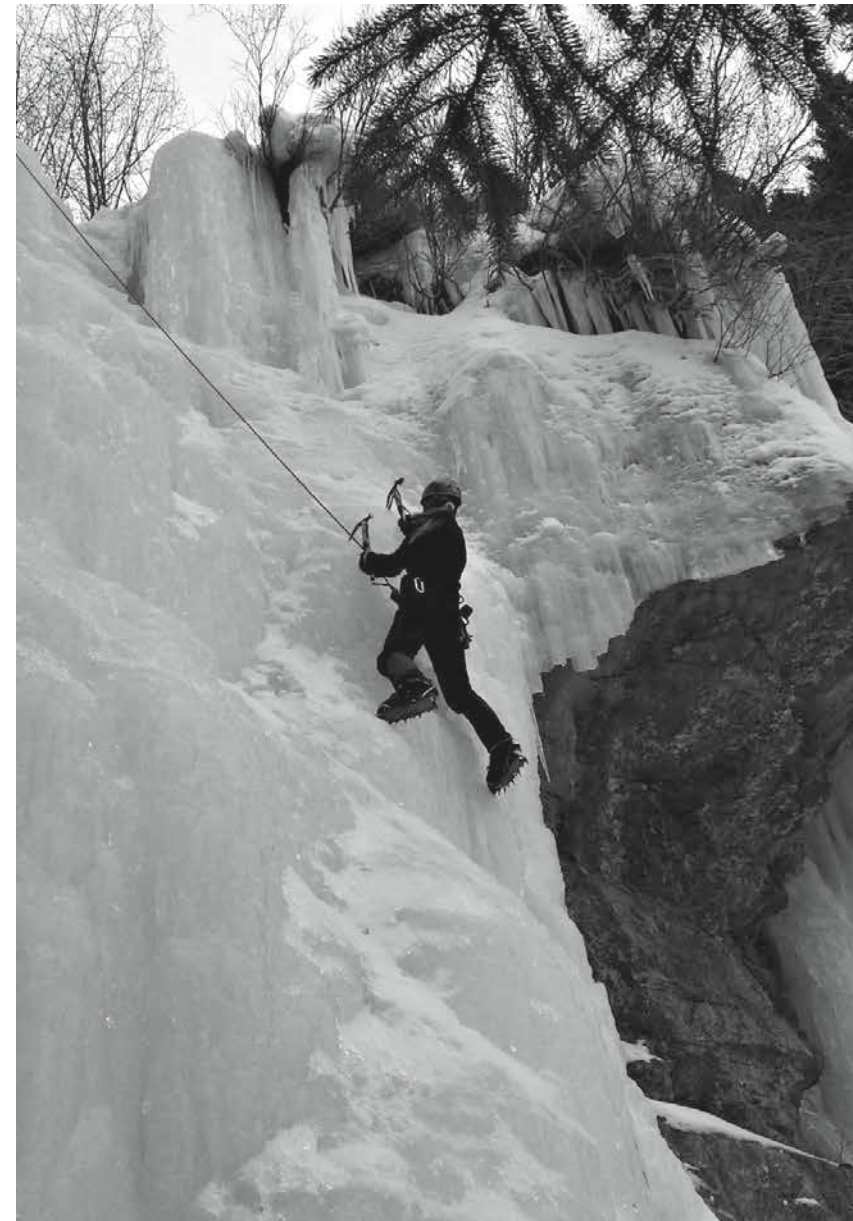

Michelle Hayes: From Farmgirl & Tomboy to Athlete & Adventurer

Michelle Hayes attributes her adventuresome spirit and competitive nature to her birth position; as the fourth of seven children, Michelle had to make her way by proving her strength and independence. “By being in the middle of seven, you get lost, so you have to create your own identity,” she says.

Michelle grew up in southern Illinois. “My father was a farmer and dreamed of having a football team of all boys, and I was the fourth out of five daughters,” she explains, “he did not even show up at the hospital when I was born! So, in order to get his attention, I had to be a tomboy.’ Who wants to go hunting?’ He would ask. I do! I do! I had to show him I was tough and rough.”

Michelle continues to share her childhood memories: “As a kid, I would go rabbit hunting with my dad. I was the pitcher on my 4-H softball team. I was the best tractor driver out of the seven children. I was responsible for 72 head of dairy cattle. My dad said I could do anything I want, as long as I milked the cows at 4 p.m. every day. I was his dairy maid until I left for college, and then he sold the herd because I was no longer there to help him.”

At Southern Illinois University, Michelle embarked on her career of competing in triathlons. To date, she has completed 78 competitions in locations ranging from Illinois, Kentucky and Tennessee to Israel, Denmark, Sweden and Estonia. Around that time, she decided she wanted to fly a plane so she took pilot training and learned to fly a fixed gear, single engine airplane to carry her from event to event.

Michelle moved to California after graduating from college and continued competing in triathlons across the country, including running marathons in Chicago and New York. A dedicated runner, cycling is really her mainstay activity that she loves the most. She laughs as she confesses, “I swim like a tugboat. I swam in a pond and never took lessons.” She loved living in La Jolla at a time when triathlons were really the rage in the early ‘80s. Keep in mind this was before the time wetsuits were sanctioned to be permitted in triathlons!

During a brief stint living in New York, Michelle was introduced to the thrill of ice climbing and rock climbing. Her destinations included the Gunks in New York and Tuckerman’s Ravine in New Hampshire. In Colorado, she climbs regularly in East Vail

on the Fang or the Pumphouse, as well as exploring Lincoln Falls near Breckenridge and Redstone near Aspen. When asked if she prefers ice or rock climbing, Michelle replies, “I like ice climbing better. Sometimes you see the waterfalls flowing under the ice. I love seeing all the formations of the ice. Something about the color of the ice, the crystals, move me more than the rock.”

Michelle first moved from CA to CO in 1987. Then after a short time in New York, she moved back in 1997 with her then 1-year-old daughter, Johanna. Upon arriving initially in the Vail Valley, Michelle first took a position as a personal trainer and aerobics instructor at Vail Cascades. In addition to her climbing, she really took to cycling in earnest and completed a number of rides including Ride the Rockies, the Triple Bypass, and the River Rides here locally. When she is juggling work and motherhood and everything else life throws her way, getting on the bike is what keeps Michelle grounded. Recently she has introduced her daughter, now 20, to the joys of riding and the pair is frequently seen pedaling between Edwards and Wolcott or Glenwood Springs when Johanna is home during the summer.

Trail running and snowshoeing round out Michelle’s portfolio of outside activities. She steps out her back door and heads straight up Arrowhead. She loves looking for feathers and has gathered a large collection of owl and hawk feathers. “I like the native American culture,” she expresses thoughtfully, “Nature connects me to everything. When I want to just get away and breathe, I just throw on my shoes and scamper up – not on the paths, just straight up.”

Michelle participates in the Vail Rec District events on a regular basis – the trail series in the summer and snowshoe shuffles in the winter – where she consistently places in her age group. She placed second in the trail run at the Go Pro Games this year. Her newest favorite event is the o2X games that is organized by Navy seals to raise money for less privileged children. The event entails scrambling up mountains hand over hand, trail running and bush whacking over all natural obstacles. Last year it was held in Winter Park and this year, Michelle will travel to Loon Mountain in New Hampshire to participate. The motto of the games is “To Rise Higher” and Michelle holds back the tears as she recalls her experience and the emotion behind the event and the cause.

Michelle’s weekly regime consists of weightlifting six days per week in addition to cardio tennis on Wednesday mornings. She says she gets ●●●

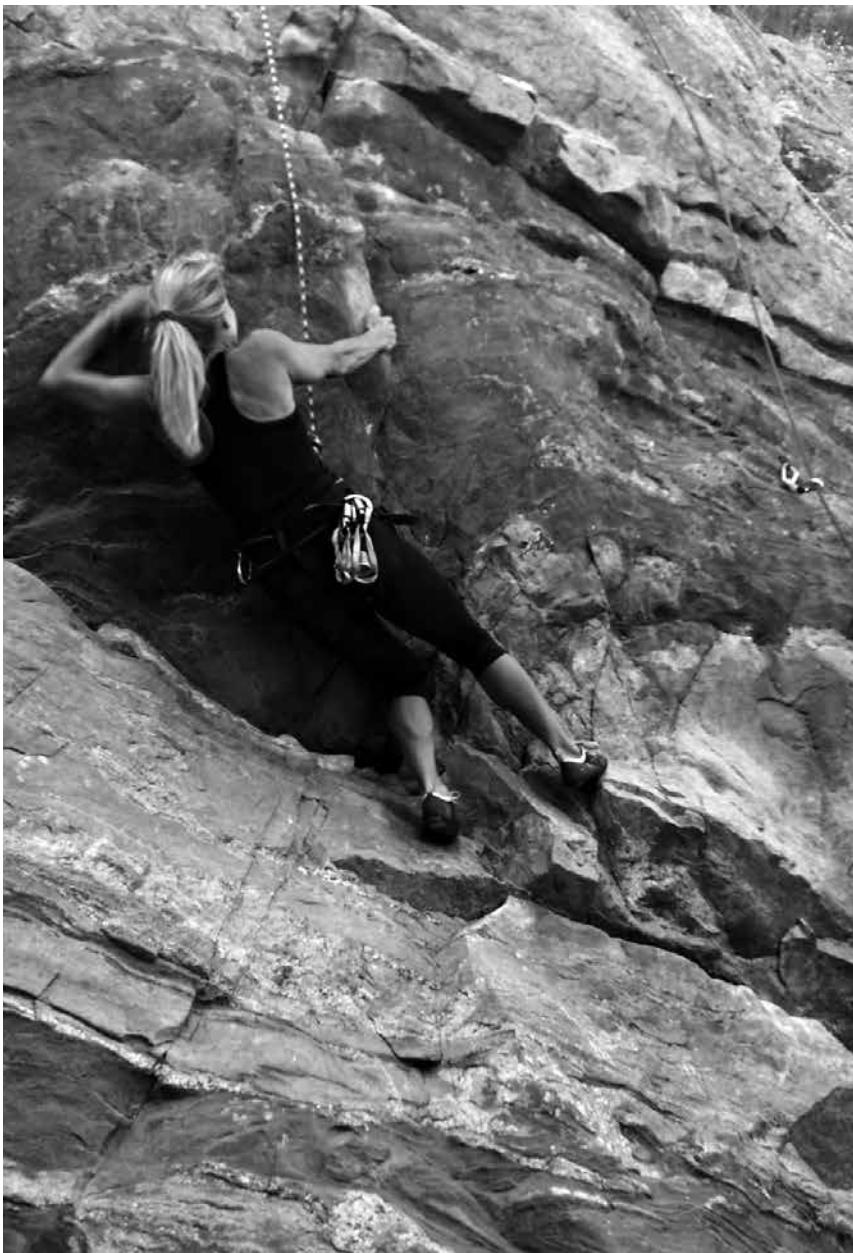
teased at the fitness center at Homestead because she is there every day, with workouts averaging a couple of hours each day. She speaks highly of the strengthening classes and says she almost feels selfish because she loves working out so much. “Whenever I am dragging, I remember how good it feels when I am finished; it inspires me to start,” she shares candidly. This has become her mantra as she lives by the words, **“You can’t finish unless you start.”**

In addition to a full athletic schedule, Michelle has built a prosperous a career in mortgage banking. Michelle loves watching Johanna grow strong and cherishes every moment they can share at Bravo! Vail concerts, or on trails runs and bike rides together.

When asked how she developed such a great sense of courage, Michelle’s response was simple. “How can you say no to something when there is nothing keeping you from doing it? I am always delighted to try something new!” From throwing hay bales to hanging from ledges, Michelle Hayes has proven she can accomplish anything she puts her mind to ... emerging successfully from being nearly lost in the middle of seven.

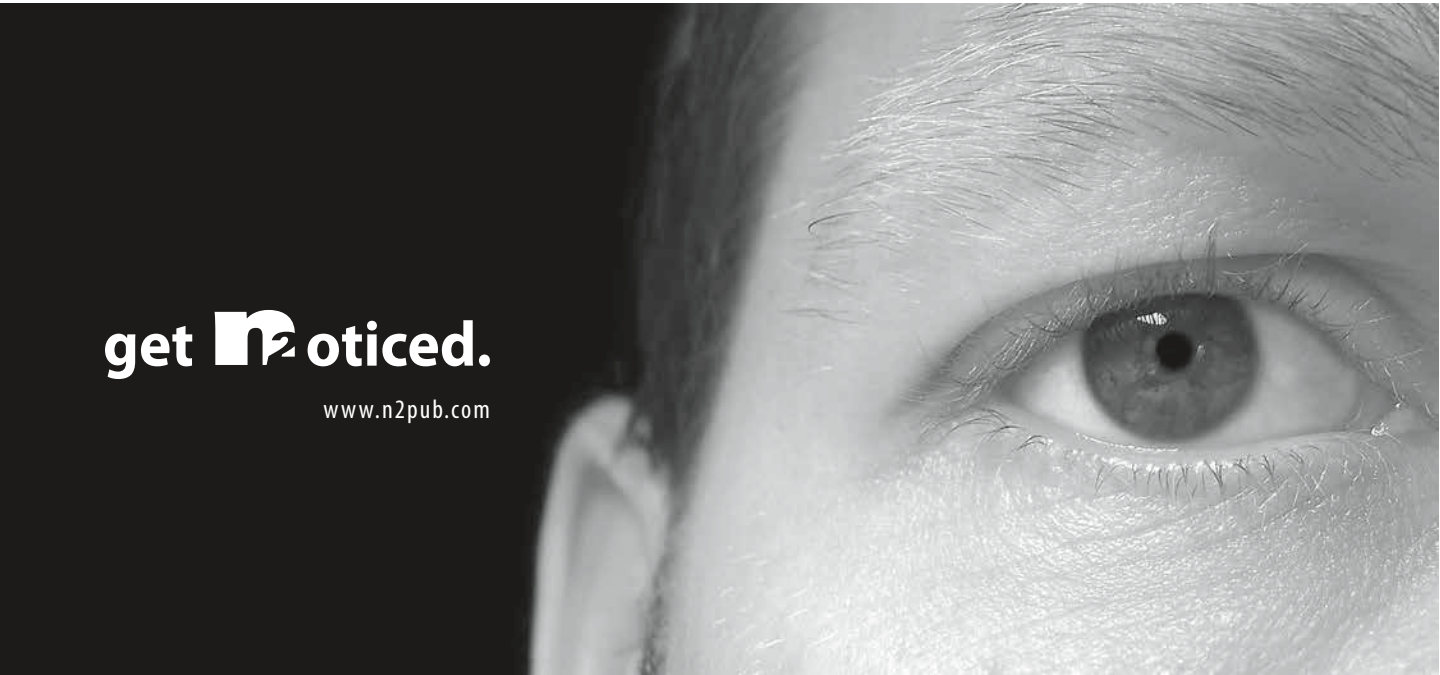

Legal Services *A LA CARTE*

As a family lawyer practicing in the Vail Valley, I have seen a great need for affordable legal representation in our community. The unbundled model of representation needs to be used correctly to avoid making a case more complicated than it needs to be.

I have spoken with the local judges on this topic at the Continental Divide Bar Association, as well as at the Family Law and Elder Law conferences attended by judges and lawyers from around the state of Colorado. We are receiving great feedback as an essential means to address the issue of a high percentage of litigants going to court without a lawyer.

The unbundled model of representation provides clients with the ability to seek the advice and counsel of an attorney prior to filing legal actions with the court. I am able help individuals navigate the court system better with the education that my unbundled services provides to them. I am able to help individuals settle all aspects of their case in mediation.

As an unbundled lawyer, I am able to draft the settlement documents for clients, and I make sure the essential areas are covered in the settlement agreement. Clients are able to reach a resolution and good outcome without spending all of their savings on seeking representation from a lawyer.

Learns Life Lessons In Tanzania

Sydney Dietz spent three weeks in Tanzania this summer teaching in the village of Arusha under a program sponsored by the Global Youth Alliance. Here she shares the highlights of her experience.

What first interested you in going to Africa?

My English teacher in seventh grade told us about the Global Youth Alliance and one of my good friends in middle school participated in the program. At the time, I felt I was too young for it and I really wasn't interested in the opportunity. Although I was interested in eighth and ninth grades, Tanzania was not an option at the time and my Mom was not comfortable with the prospect of me going to Cambodia or Nicaragua. Finally, my sophomore year I convinced her to let me go and by then, Tanzania was an available option.

What was entailed in the application process?

I wrote an essay and then had an interview. There was a week of interviews at the Avon library, and about a week later, I got a phone call and was told I had been accepted! There were about 50 Vail Valley students accepted by the Global Youth Alliance, 12 of which went to Tanzania and others went to Nicaragua, Morocco, Nepal or Cambodia.

Why did you select Tanzania? The service work we were going to do was teaching and I want to be

a teacher. Also, my aunt is from Africa, adopted on Mom's side, and my Dad and his sister have travelled to Africa and loved it.

How long were you there? I left July 15 and returned August 3.

Where did you stay? We stayed at a guest house that was arranged by the woman who organizes the program. It was a house about 20 minutes from the center of Arusha and it was a mansion compared to everything else there. It was very comfortable, cozy and safe, gated, with a guard.

What grades was the school and what did you teach? The school was for classes from Baby (age 3) to Class 7 (age 15). I taught Kindergarten the first week, Class 4 the second week, and then spent a couple of days in Class 7.

Did the school provide the curriculum? Kindergarten is very strict so they told us what we needed to teach. In Class 4, it was the week before exam week and the teachers wanted us to help the kids review for exams. It was really scary because the teachers left us in the classroom and we had to stand up in front of about 20 kids, ages 9 and 10, and come up with ways

to get them engaged. It turned out to be really fun because we invented new games for them like 'Around the World' where the kids had to race each other to see who could answer the question first.

How would you describe your students? The students respect their teachers so much. The teachers are very strict. The kindergartners are much better behaved than the kindergartners in America. In Class 4, the students have been disciplined to learn the importance of their education. They understand that getting an education is such a treat and they are excited to be there. The kids in Class 7 are very serious. After completing the year, they have to apply to secondary school (which is like high school) and they have to be accepted. If they are not accepted into a government school, they have to pay to go to a private school.

Was your school a private school? Yes. The families had to pay for the students to be there, which is not possible for so many of the population. About half of the students are there on scholarship.

Did you see where any of these students live? We visited the homes of some of the students who were on scholarship. One home was smaller than the size of my bedroom, with a bed, a table, and not even a kitchen, just buckets. The woman who lives there is blind. She has two sons, ages 9 and 11. I have no idea how she does it but she is the most amazing woman I have ever met. She says her faith in God keeps her alive, and the only picture in the house is a picture of Jesus.

What language is spoken in Tanzania and did you learn to speak it? The official languages are Swahili and English. I learned "asante" which is "thank you" and when someone greets you and says "mambo", you reply "poa", otherwise it is disrespectful. When

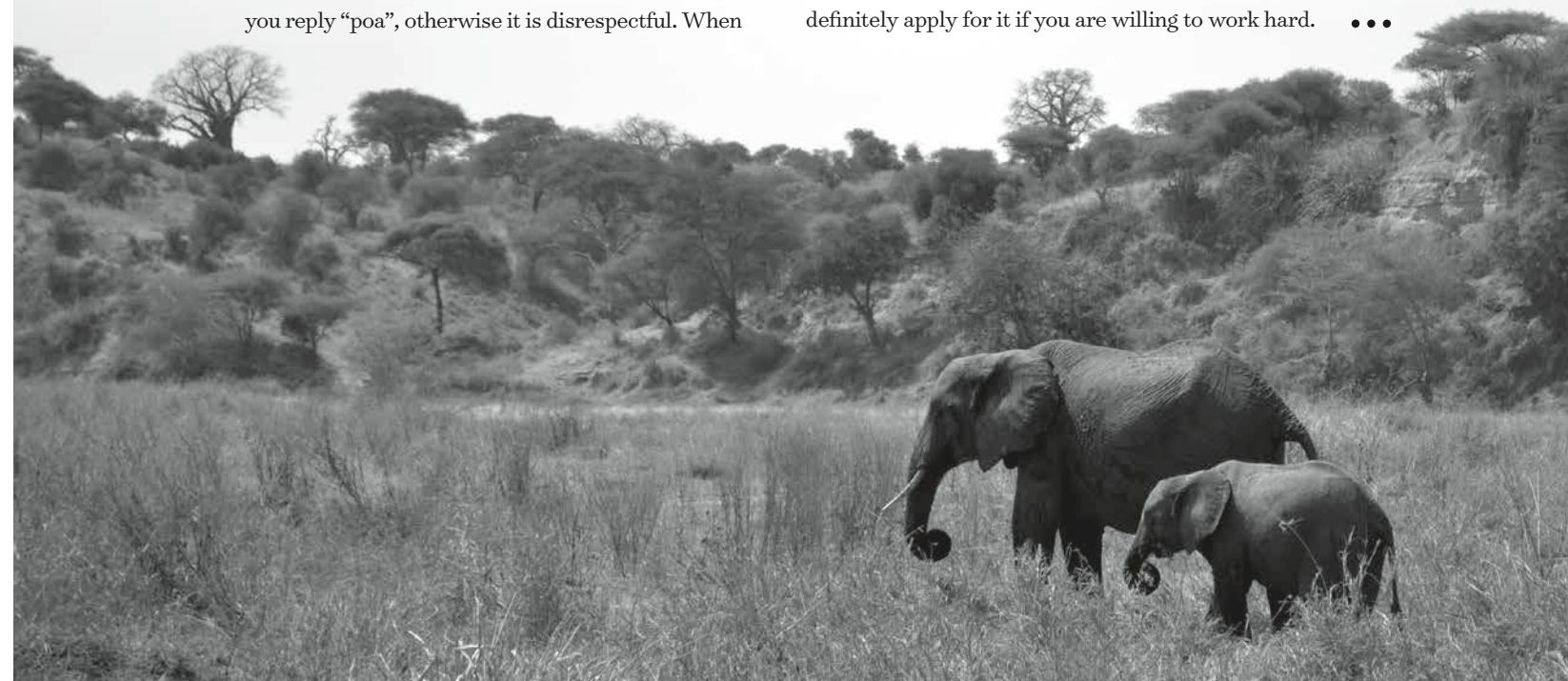
someone greets you, they ask how you are doing, they look you in the eye, shake your hand, and they are sincerely interested in your answer, unlike in America where people don't really listen to the response. The people there are much more genuinely engaged.

What other cultural differences did you notice? They don't really believe in time, meaning if school starts at 8:00 am, teachers would arrive at 8:15 a.m. and it was not unusual for kids to be late. But the kids were late because they were likely helping a neighbor or friend in need. At orientation, a Swahili teacher told us that if someone is late for class, you could not be mad because people should always help others. Here, you get in trouble if you are five minutes late, but there, it is more important to help others.

What experience had the greatest impact on you? I learned how selfless the people are there. We were driving to visit an African tribe and there was a man setting up fireworks for a small audience. He was dirty, his clothes had holes; it looked like it might have been the only shirt he owned. He was eating a piece of corn. The windows on the bus were open and he came running up to the bus offering us the corn, "Eat! Eat!" he said. Here we are, a bus of tired white people and he was offering us food. So selfless.

What else has stayed with you? Just how close we came with everyone there – with the students – everyone was crying when we left, even the driver who drove us to school every day was in tears. It was very emotional; I was so sad to leave all of the students. I miss them so much.

What advice would you give an eighth or ninth grader who is considering going to Tanzania with the Global Youth Alliance? I would say definitely apply for it if you are willing to work hard. ●●●



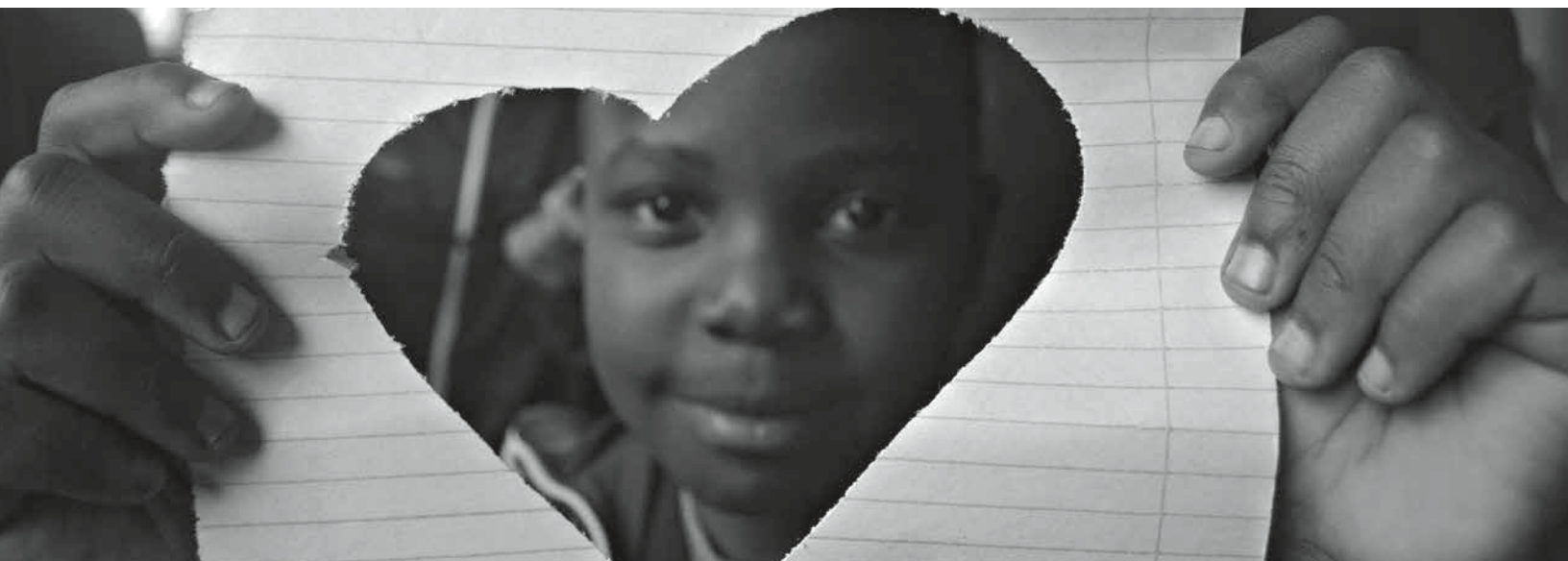

Going into it, you need to know that you are there to help the kids. It is not just a safari the entire time; you have two hours each night of lesson planning and then you are at school all day. You have to give everything you have for the kids.

What is the biggest life lesson you learned from your experience in Arusha? I think to be more selfless myself. Even kids on scholarship, they have one uniform to wear every day and sometimes it is dirty or has holes in it, but they hold their chin high and walk into the classroom, ready to learn and to work hard, regardless of what is going on at home. The biggest lesson I learned is to value my education more.

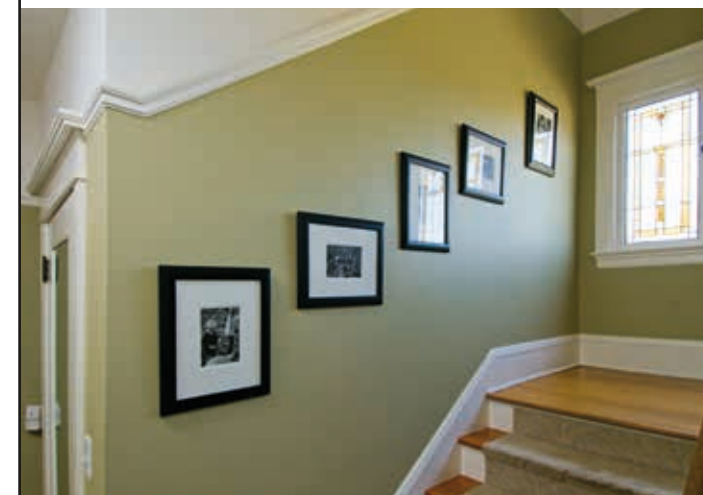
