John Perkins presented the landscape revisions which will include the removal of 3 trees and the front yard will be sod.

A motion was made to approve the landscape revisions, which will include the removal of 3 trees and the adding of sod to the front yard. By motion duly made and seconded, it was unanimously

Larry Rogers, project Architect, presented the conceptual plans to the Committee for their review and the following matters were noted:

- a. It was generally agreed by the Committee that the two entrance stairs on the exterior of the building were awkward and the entrances would benefit from having more variety.
- b. The Committee expressed concern that the two sides of the duplex appeared to have a mirror image, driven by the mirror image floor plans.
- c. It was suggested that a side-loaded garage on one of the units would be beneficial to the south elevation and the overall composition of the duplex and would be preferable to having two front-facing garage doors.
- d. The Committee suggested positioning the north wing of the west unit further to the north, indicating that this could provide some protection and privacy from the golf course.

Barry Monroe, of R.A. Nelson (the project's builder) was present to propose 2 project signs for the Sonnenalp Golf Club addition. The proposed signs are to be 4' x 6' with one sign used as an information sign for the project and the second sign would be a rendering of the proposed addition to the Club House.

The Committee indicated that the official project sign must comply with the Design Guidelines (Design Guidelines page 31, Section 5.3) as far as the content, maximum size allowed (24"x36"), location and installation. This information is required by Eagle County and is in part is required in the case of an emergency.

The proposed informational sign and rendering sign could be located closer to the entrance to the clubhouse for marketing and informational purposes.
