- Obtain bids to replace the back deck on Building A. Consider wood decking, a synthetic wood option and a paver patio.

OTHER BUSINESS

It was agreed to continue charging AA groups meeting in the board room a monthly charge of \$25/meeting/week.

MOUNTAIN RECREATION'S DONATION REQUEST FOR ICE RINK COSTS

Mountain Recreation plans to provide an outdoor ice rink at the Edwards Field House this winter. They anticipate startup costs to be approximately \$20,000 and are requesting a \$5,000 to help with those start up costs. The board discussed the value to Singletree residents and following the discussion, by motion duly made and seconded, it was unanimously

RESOLVED to donate \$5,000 to Mountain Recreation to help with the startup costs for an outdoor ice rink at the Edwards Field House.

OPERATIONS

- Dan Carlson and Mike Reisinger continue working on the Berry Creek Metro District Operational Activities manual.
- Tree trimming has begun in the chosen parks and is nearly complete at Chip Ramsey Park.

AUGUST FINANCIAL REPORT

Dollars will be re-allocated from Capital Projects to Playground Equipment to accurately reflect how the dollars were spent. The 2021 budget work session was scheduled for Wednesday, October 21, from noon to 2 PM. Following the discussion, by motion duly made and seconded, it was unanimously

RESOLVED to accept the August 2020 financial statement as presented.

PAYMENT OF SEPTEMBER INVOICES

There was a question about the timing of utility bill payments and when they are ratified at meetings. It was explained that utility bills typically auto-pay on their due date and are ratified by the board at the meeting, this is true of contract work as well. Following the discussion, by motion duly made and seconded, it was unanimously

RESOLVED to approve the September 2020 invoices for payment.

UPPER EAGLE REGIONAL WATER AUTHORITY UPDATE

Customers can expect 16% to 20% annual increases in their water charges due to capital project expenses and changing regulatory requirements. It was noted that operational expenses are covered by water use revenues.

COMMUNITY MANAGER'S REPORT

- The bear are very active in Singletree right now. Another email will be sent out to residents to be bear aware.
- There has been a request to have the BCMD board consider re-opening the gym at the October meeting.
- The boards encouraged, hopefully along with the town of Avon and other partners, to create a safe I-70 cleanup day this fall.
- The Boards requested a meeting be set up with Sheriff van Beek to review road right-of-way policy and enforcement in Singletree.

There was no other business.
