


hris and Brenda Case fell in love with the Vail Valley even before they were "The Cases." Chris grew up in Fargo, North Dakota, and Brenda in Houston, Texas. But after graduating from college, both found that the mountains were calling. So each lived in a ski town for a year, before moving to Denver for work. Chris, who now specializes in finance for large transportation, aviation, construction, and manufacturing companies, graduated from Concordia College in Moorhead, Minnesota. He earned a Bachelor of Arts and began his career in Denver's booming trucking business. Brenda earned a Bachelor of Journalism in Public Relations from the University of Texas at Austin and went on to become the Marketing Director for Colorado Studios and Mountain Mobile Television, a production facility and remote television company, whose clients specialized in Major League Sports and entertainment.

When they were first set up by mutual friends in 2000, they spent many evenings attending Colorado Avalanche, Denver Nuggets, and Colorado Rockies games, and also enjoyed the growing excitement of living in Denver. But one year later on Martha's Vineyard when Chris proposed, they knew for certain that they would get married on a quiet mountaintop in the Rocky Mountains. Always the planner, Brenda quickly booked a wedding coordinator to show them options in the Vail Valley. And it was an easy decision to opt for a Fall wedding at the rustic and elegant Beano's Cabin, which sits mountainside at Beaver Creek Resort. "We always knew we wanted to get married in the mountains. And after choosing Beano's for such a special event, we just kept coming back again and again: anniversaries, ski seasons, summertime, Octoberfest, we loved







it all," explained Brenda. At the time it was a quick trip up and down I-70 to get out of the city on a whim and spend a long weekend in the mountains.

Once they started having kids, though, a little more planning was involved to get away. But the Cases made sure that all three of their sons — Cash (15), Jasper, and Major (both 9) — learned to ski as soon as they learned to walk. Chris states, "I had a childhood friend who lived in Avon, whose kids all participated in an awesome race program. Once our oldest son Cash was in first grade, he started ski racing with the Buddy Werner League (BWL) of Vail/Beaver Creek. So from December to March our family would pack up every weekend and drive to the mountains for training and races." With one child and two babies in tow, driving back and forth from Denver and renting on the week-



ends became a daunting task. It started to feel like they were living two lives —one in the beautifully historic neighborhood of Park Hill, located in the heart of Denver, for six months of the year, and the other six months in the car, always packing and unpacking bags.

So the family decided it was time to buy

something in the mountains. After looking mostly at slopeside options, they opened up their search and found a listing for a condo on the 9th hole of the Sonnenalp Golf Course in Singletree. The Cases immediately fell in love with the views, the sunny weather, and the comfortable neighborhood feel. Brenda (who after having children changed careers to flipping homes, mostly from the turn of the century) thought their condo project would be an easy remodel and made sure to complete the renovations before their family's first Christmas in December 2016 at their new home away from home. Then their latest routine consisted of leaving Denver early on a Friday after the kids got out of school and returning home on Monday mornings, many times in traffic and snowstorms!

Though skiing was what initially brought them here, Chris and the boys wanted to extend their season longer with Summer fishing, Fall hunting, and late Winter snowmobiling, not to mention the amazing golfing just steps away in their backyard. Brenda jokingly notes that all four of her family members (plus their Yellow Lab Junebug) decided to move up to Singletree full-time before she actually did: "Chris and our three boys were the first ones to say they wanted to try living up here year-round, so I eventually softened to the idea since I was the holdout." Looking back, Brenda said moving was actually a pretty easy decision. Even though she loved living in Denver, things were definitely starting to get a little hectic. So craving a slower pace for their family with a small-town feel, the Cases finally decided to leave Denver after 20-plus years, and started to look for a new home. But there was one stipulation from Brenda: only if it was in Singletree!

The idea of a true neighborhood with stunning scenery and endless sunshine appealed to her. And the family was excited to learn that there was a little Catholic School in Edwards, where their youngest boys Jasper and Major could easily transition from their school in Denver. They also wanted to get their oldest son Cash settled up here before he started high school as a freshman



at Battle Mountain. So the Cases planned to make the move in January 2020. Brenda said, "It actually happened really fast! After five years of deciding, once we said we wanted to move, some people in our neighborhood were always asking if we'd sell our home, and this time we just said yes!"

Settling in has been easy in lots of ways for the Cases. "Even though we only moved up here two months before the pandemic, people in the neighborhood were so welcoming. And after being stuck in our condo during COVID 19, joining the Sonnenalp Club seemed like a great way to get outside and make the best of the lockdown," said Chris. Everyone now has their favorite things to do up here. Chris is an avid golfer and skier, plus he loves coaching BWL racing. Brenda enjoys snowshoeing and has kept busy by volunteering at their sons' schools and sports while meeting new people in the Valley. 





Meet Your Eagle County Clerk & Recorder:

Regina O'Brien

who's making a difference Contributed by **Regina O'Brien**, Singletree Resident

"What exactly does the Clerk & Recorder's Office do?" I am often asked this question when I tell people I am the Eagle County Clerk & Recorder. Unlike the County Sheriff's Office or the County Treasurer's Office, my office title leaves people wondering.

Divisions in the County Clerk's Office

There are five distinct divisions in the Clerk's Office. The first is the Recording Division which is responsible for filing and maintaining county real estate ownership documents, making them available for public search. Such documents, which date back to 1883, include deeds, mortgages, liens, foreclosures, etc. In addition, the Recording Division issues marriage licenses.

The second division is the Clerk to the Board of County Commissioners. In this role, the Clerk's Office supports the three County Commissioners by recording, transcribing, and preserving the records of their proceedings in perpetuity.

Our Clerk to the Board Administrator also issues liquor licenses and special event liquor permits for unincorporated businesses and events in Eagle County. We assist many of the small businesses and non-profit events in Edwards, Beaver Creek, and other unincorporated areas of the county, such as in the Roaring Fork Valley, to ensure they have the proper liquor licenses in effect.

Motor vehicle titling and licensing services are also assigned to the Clerk. The Motor Vehicle team acts as agents on behalf of the Colorado Department of Revenue to issue ownership documents and license plates to all vehicles in the



county. With over 60,000 registered vehicles in Eagle County, the Motor Vehicle Division is a fast-paced part of the office's operation.

Finally, the Clerk's Elections Division oversees the administration of elections for Eagle County. Election work never stops in this part of the office. When we are not actively running an election, we are meticulously performing maintenance to our voter records, preparing to administer the next election, and keeping abreast of legislative changes.

My Path to the Clerk's Office

After explaining what the Clerk's Office does, I am often asked how I found my way to this role. My educational background (Government and International Relations degree from the University of Notre Dame and an M.B.A. from the University of Oregon) combined with my professional experience in management and customer service led me to the Clerk's Office in 2013. I was hired by then Clerk & Recorder Teak Simonton as the Chief Deputy Clerk & Recorder,

helping Simonton run all the divisions within the office. Simonton was elected in 2016 as the Eagle County Treasurer, thus I was appointed to the Clerk's role to serve out her term. I was elected to the position in 2018.

The 2020 Election Season & the Critical Role of **Election Judges**

As you can imagine, the 2020 election cycle kept the Elections Division of my office incredibly busy. The November General Election concluded a string of four elections in Eagle County, starting with the November 2019 Coordinated Election, continuing with the March 2020 Presidential Primary, the June 2020 State and Local Primary, and closing with the November 2020 General.

All of Eagle County's elections ran successfully, and that is in large part due to the dedication and service of our citizen election

NOVEMBER 3, 2020 EAGLE COUNTY GENERAL **ELECTION FACTS**



General Election Turnout:

- 86% of Eagle County voters returned their ballots (29,506 ballots cast out of 34,255 active registered voters).
- 70% of voters returned their ballots before Election Day.

Ballot Return Methods:

- 67% of voters returned their ballots at a 24-hour ballot drop box; this was the most popular return method.
- 17% of voters returned their ballots by mail, the second most popular return method.

Voting Methods:

• 95% of voters chose to vote their mail ballot with the remaining 5% choosing to vote in-person at a vote center in the two weeks leading up to Election Day.

Election Audit:

- Eagle County passed the state-wide post-election risk-limiting audit (RLA) with zero discrepancies. RLAs have been conducted in Colorado since 2017, and Eagle County has passed each and every one with a perfect score. 2020 was no exception.
- COVID-19 Impact: All three 2020 elections were managed through the COVID-19 health crisis, and there was not a single reported case of disease transmission on the team or with our judges.

services, and post-election auditing. Our fantastic judges worked in bi-partisan teams to ensure all 2020 Eagle County elections were conducted fairly, accurately, securely, and transparently.

Working with our citizen election judges is one of my favorite parts of election administration. Democratic, Republican, and Unaffiliated judges work side-by-side to help every single Eagle County voter and to ensure that every vote counts. No matter the personal beliefs or politics, we share the same goal to conduct the election with integrity and accuracy. It's an honor and a privilege to work with all of our Eagle County election judges, several of whom are our Singletree neighbors! Please keep an eye out for the next issue of the magazine when we will feature many of the members of our community to learn more about their personal experiences as a judge.

Serving as an election judge is a great way to learn about the conduct of elections in Colorado as well as a way to serve the community. If you are interested in learning more about becoming an election judge for the upcoming November 2, 2021, Coordinated Election —or for any future election— please contact the Clerk and Recorder's Election Division at elections@eaglecounty. us or 970-328-8715. Election judges must be registered voters in Colorado and pass a Colorado Bureau of Investigation background check. In addition, high school students can be election judges if they are 16 years of age or older and either a junior or senior. Parental or legal guardian's consent must be given for a student to serve as an election judge.



came home for Christmas


break from Baylor University, we all jumped in the car to choose our new puppy! This sweet puppy caught all our hearts and we took her home that day.

teamwork Improves the ASC Trail









In late May, Lee Rimel, along with Jim Knez and a crew from SHC Nursery & Landscape Company, upgraded the Singletree trailhead for the Avon Singletree Connector (ASC) trail at June Creek Road. The drainage culvert was deepened prior to placing the limestone bridge to aid in water drainage during our rainy season. In addition, locally available rocks were added to strengthen the culvert.

Twenty-five gallon buckets of road base (donated by Lee) were spread on both sides of the bridge to prevent the trailhead from turning into a muddy bog after rainstorms. Signage was moved to conform to the new trail and additional barriers were added to the existing trail to encourage hikers and mountain bikers to remain on the trail as they descend to the trailhead. 





I first skied in Colorado in 1977. I was a senior in high school. I came to Vail with three friends. I was awestruck by how massive Vail and the surrounding mountains were. And when I first laid eyes on the back bowls, I thought I had died and gone to heaven. That was when I first fantasized about living here someday.

Over the course of the next 53 years, I returned to Vail dozens of times, initially for skiing and eventually during summers as well. My kids learned to ski here. The Vail Valley became our family's spiritual home.

I dreamed of skiing every day in winter then golfing, cycling, and hiking during the off-season (which I have since discovered is the on-season). But as an attorney from New York with a wife, kids, a mortgage and college tuition payments, I never actually thought that dream would ever come true. I never thought I would leave everyone and everything I knew to come to a place where I knew absolutely no one.



And then it happened. I woke up one morning in August 2019 and I knew it was my time. The stars were aligned. I had just turned 60. I was divorced and unattached. 




