- a. The Committee cautioned the applicant to be mindful of Eagle County's fire restrictions in relation to the proposed gas fire pit.
- b. All windows in the home will be replaced.
- c. The applicant has requested a wider driveway but it can not be located in the setbacks.

## **Lauterbach Duplex**

Lot 43, Blk. 1, Flg. 4 43 Morgan Drive **Preliminary Review** 

Mike Lauterbach and Steve Riden presented the preliminary plans to the Committee for their review and the following matters are noted:

- a. Cap flashing details are required.
- b. The oversized garages are still a concern to the Committee as they could potentially become living space. Note on the plans where the trash cans will be located.
- c. The deck rails are to be ¼ "steel bands and area detailed on the plans.
- d. Again, the Committee suggests that the Applicant consider lowering the finish floor elevation of the duplex to help with the driveway design while eliminating the need for steps to the main entries.
- e. The window fenestration continues to be weak.
- f. Reconsider the roof color as it reads too light. Medium bronze or khaki would work.
- g. The garage doors must be clad with 1" x 6 "T&G. and details are required.

The matter is tabled at the Applicant's request.
