IMPORTANT INFORMATION

- All requests to install mechanical equipment and air-conditioning condensers on the exterior of a home shall be reviewed and approved prior to installation by the Architectural Consultant and/or the Design Review Committee.
- Mechanical equipment and air-conditioning condensers installed on the exterior of a home in Singletree are allowed under the following guidelines:
 - All equipment shall be installed within the setbacks and **as close** to the home as possible.
 - All equipment shall be screened from view from adjacent property owners and public property with evergreen landscaping, including trees and/or large shrubs.
 - If terrain or proximity to other structures or uses limits the ability to screen air-conditioning equipment with evergreen vegetation, the DRC may require a screen or fence to be constructed. Fences and Walls (Section 3.3) must be installed within the required Setbacks (Section 2.3).
 - All conduit, wiring, and refrigerant lines shall be located inside the wall(s). No conduit, wiring, or refrigerant lines will be approved on the exterior.
 - Air-conditioning condensers shall have a 10 or higher SEER (Seasonal Energy Efficiency Ratio) rating and noise output shall not exceed 60 decibels as measured from any property line.
 - Duplex lots shall be required to submit a Duplex Owner Written Approval Letter.
