The color inspiration is the existing contemporary duplex on Chaparral Road. The entry structure will be rebuilt with a new pitched roof structure. Wood siding will be added around the dining room and bedroom window bump outs. All steel channels will be black to match the new windows and new black deck rails. Any notched roof line will be straight across, and rounded corners will be squared off. New large sliders will be added at the deck. The existing driveway will be replaced and widened. There are no setback issues with the driveway widening.
