**Fickling Residence** 

Lot 20, Blk. 4, Flg. 2 0040 Miller Place Remodel

Rusty Buick presented the plans to enclose the porch deck to the Committee for their review and the following matters were noted:

- a. The trellis has faded, the Committee recommends re-staining that portion.
- b. The siding is to be installed so as not to show a butt joint line.
- c. All galvanized metal is to be painted out to match the existing/adjacent finishes.
- d. All exterior lights are to be down light and cut sheets are required if they are not in compliance (Section 3.13)
- e. Green plastic netted construction fencing is required and must be indicated on the site plan.
- f. Foundation details are required.
- g. The deposit will be \$3,000.00

By motion duly made and seconded, it was unanimously,

**RESOLVED** to approve the enclosure of the porch deck subject to the conditions outlined above.
