Johnson Residence

Eric Johnson presented the plans for the solar installation to the Committee for their review and the following matters were noted:

- a. A Mansard style copper chimney cap will be added.
- b. The mono-crystalline solar panels are a "Suntech" Black Label STP175S 24/Ab-1
- c. To be installed 6 ½" above the plan of the roof per detail.
- d. The aluminum ends will be painted to reduce visibility.
- e. The relevant part of the existing cedar roof will be re-shingled to match the existing.
- f. A deposit of \$3,000.00 is required.

A motion was made to approve the solar panels and installation subject to the conditions outlined above. By motion duly made and seconded, it was unanimously

The Architect for the project, Mike Hazard, and the owner, Ms. Marcellot, were present to further explain to the Committee why the garage addition was not constructed according to the approved plans of August 13, 2009, and propose solutions that might be acceptable to the Committee. Mr. Hazard proposed engaging the two roofs with a cricket and changes to the fascia. Ms. Marcellot reiterated that she will have stonework wrapped around the existing pillars and planters. The height of the stone will be 36". A photo of the stone was submitted for review. Ms. Marcellot has eliminated the plans for up lighting and installed caramelized down lights. After discussion, by motion duly made and seconded, was unanimously

RESOLVED to approve the engagement of the two roofs with a cricket and the changes to the fascia.

The Committee requests that photos of the rear of the building and color board and a landscape plan be submitted showing plantings, additional soil and/or boulders. The proposed galvanized metal will be replaced with copper. A revised color board is must be submitted. The Applicant is allowed to start the front stone work.

RESOLVED to approve the immediate commencement of the stonework as shown in the photograph submitted at the March 25, 2010 meeting.
