John Martin, architect, and Sandy Treat, owner, presented final plans for a new duplex. Since the last submittal, the proposed parking in the setback has been eliminated, the roof form

collision on the back of the duplex has been resolved with a new lower center roof form, and the connection on the east side of the duplex has been resolved. It was noted that the plans indicate the fascia will be metal and it is planned as dark walnut stained wood to prevent oil canning in such a large piece of metal. The roof pitch is 1 ½:12.

The DRC commented on the improved color scheme and appreciated the wood fascia rather than metal as indicated on the plans.
